Refund Rules: The Schedule of refund of fees will be as follows (in line with the UGC rule October 2018): If a student chooses to withdraw from the programme of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

3.	80%	15 days or less after the formally-notified last date of admission (from 22 nd August 2021 to 5 th September 2021)
4.	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (from 6 th September 2021 to 20 th September 2021)
5.	00%	More than 30 days after formally-notified last date of admission (from 21 st September 2021 onwards)
