**B. Sc. - Mathematics (Honours) (Batch 2022)
Admission Information Handout**

1. **Introduction: School of Mathematics & Statistics** has its first batch of students from 2019, Mumbai Campus. It's a 3 year program and degree awarded is **B.Sc.-Mathematics (Honours.)**

This booklet gives information about the Admission Procedure for **B.Sc.–Mathematics (Honours)**, Mumbai campus.

Duration: Three years, full time programme.

2. **Eligibility Criteria:** (Fulfilment of all applicable conditions mandatory)

- 2.1 A candidate must have passed 10+2 or equivalent examination from any recognized board and must have obtained a minimum of **75% aggregate** marks **with Mathematics** at their 10+2 or equivalent examination.
- 2.2 A candidate who has passed 10+2 or equivalent examination from IB Board should be either IB certificate or DP or CP awarded candidate with 24 credits compulsory, having passed 3 HL & 3 SL mandatorily from any stream. The Candidate with IB Diploma/ CBSE is eligible if he /she has offered Mathematics at Standard Level (SL).
- 2.3 Candidates of CBSE & ICSE, should mention in the online registration / e-admission form (if selected) 10+2 or equivalent aggregate marks of all the subjects for which the candidate has taken & appeared for **(not best of four, five, six or seven)**. The candidate shall have passed all the subjects taken & appeared for in the applicable examination/s. The aggregate percentage of all subjects for which the candidate has taken & appeared will be taken into consideration for confirming eligibility of the candidate for the program at the time of admission.
- 2.4 In case the mark sheet issued by the applicable Board / Institution is in percentile/s, the actual aggregate percentage of all the subjects appeared by the candidate will be taken into consideration.
- 2.5 Candidates **above 25 years of age are not eligible** to apply.

2.6 For IB & Cambridge Candidate:

Candidates called for admission on the basis of merit list & who do not have final mark sheet will be given "Provisional Admission" based on predicted scores. Fees will be accepted from such candidate but their admission will be confirmed on submission of final mark sheet before the commencement of the program if found eligible.

Mark sheet / Transcripts issued by Board / University only be considered (School / Institute will not be accepted)

2.7 Submission of AIU equivalence certificate to confirm the eligibility for the program is mandatory for those candidates who have completed their (10+2) examination from Overseas Universities.

2.8 Those candidates who have passed or are appearing for 10+2 examination from a Board / University where Grade Point Average is given, such candidates must produce in writing from the Board / University concerned, the equivalent percentage for the GPA / CGPA obtained.

2.9 Candidate whose final mark sheet is not available at the time of admission is required to submit internet copy of result or Digi locker copy of result, duly attested by Principal of the school / college, failing which candidate will not be admitted for the program.

2.10 **Only single mark sheet with all compulsory subject taken / opted and passed will be consider. Compartmentalized mark sheet will not be considered.**

2.11 Candidate will not be eligible if any subject is marked as ungraded / fail in the mark sheet / grade-sheet. For absent / ungraded in any of the additional / non mandatory subject will be consider as eligible provided such candidate is declared as pass by respective board.

As per program eligibility, the mandatory subject should be appeared and passed.

2.12 Candidate appearing for their final 10+2 or equivalent examination can also apply provided they obtain the required minimum cut off marks and also produce the entire necessary documents, in original, within the given stipulated time.

2.13 Candidates can also apply on the basis of **SAT score**. For more details, visit <https://nmims.edu/admission-sat> There will be separate merit list for SAT and a separate merit list for NON SAT.

SAT Candidates need not appear for NMIMS - Online entrance test.

3. Admission Process:

3.1 Online Registration & Payment of Registration Fee.

- Visit www.nmims.edu for online registration.
- Pay registration fee of Rs. 2000/- (Non-refundable) (Please refer online Registration for payment details.)
- Before filling the online form, please read all the instruction carefully mentioned in admission information handout & important dates.
- Registration Fee is non-refundable.

3.2 Selection Process

The selection will be based on Merit Score of 2 parameters as below; The cut off for deciding the merit shall lie with NMIMS.

- 1 Scores of 10th Std Mathematics.**
Weightage = 25%
- 2 Scores of NMIMS - Online entrance test.**
Weightage = 75%
Total: 75 marks. Weightage = 75%

The Objective type NMIMS - Online entrance test will be based on Class XII Mathematics only. Topics will include Numbers, Algebra, Geometry. Basic Calculus, Set and functions, Statistics and related subjects.

Details related to Objective type entrance exam date will be updated on website, Mailers and SMS will be sent to candidates, confirming date and time for the online test and the requirements related to the test such as laptop, desktop, etc. Please ensure you have entered the correct email id and mobile number in your registration form.

- **Candidates are required to update the relevant details in online application form on or before the last date of registration i.e 10th July 2022.**

- The Merit list will be put up on the NMIMS website as per important dates. The decision of the institute will be final in this regard and no inquiries or correspondence in this regard will be entertained.
- Admission offer is given as per merit and vacancy. Selected candidates should proceed for payment of fees within the stipulated time as per important dates.
- Waitlisted candidates have to check their merit list status regularly.

3.3 Programme Fees for batch 2022:

Programme fees for 1st year B.Sc. – Mathematics (Hons), academic year 2021 was **Rs.1,50,000.00** p.a.

Programme fees for 1st year B.Sc. – Mathematics (Hons) for Batch 2022 will be declared at the time of admission.

4. Refund Rules:

If a student chooses to withdraw from the programme of study in which he / she is enrolled, the institution concerned shall follow the following five-tier system for the refund of fees remitted by the student.

Sr. No.	Percentage of Refund of Aggregate Fees	Point of time when notice of withdrawal of admission is served to HEI
1.	100%	15 days or more before the formally-notified last date of admission (on or before 5th August 2022)
2.	90%	Less than 15 days before the formally-notified last date of admission (from 6th August 2022 to 21st August 2022)
3.	80%	15 days or less after the formally-notified last date of admission (from 22nd August 2022 to 5th September 2022)
4.	50%	30 days or less, but more than 15 days, after formally-notified last date of admission (from 6th September 2022 to 20th September 2022)
5.	00%	More than 30 days after formally-notified last date of admission (from 21st September 2022 onwards)

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount subject to maximum of Rs.5000/-

Note :

1. The above refund rules are subject to revision as applicable.
2. Candidates to refer Important Dates of the respective programme.

5. Important Instructions:

- Cancellation / withdrawal of admission:
Withdrawal / cancellation means voluntary withdrawal / cancellation by candidate for any reason. Please use the below link for admission cancellation form.

Candidate has to upload cancellation form duly filled and signed along with fees paid receipt copy & cancelled cheque (personal account).
- Canvassing in any form for admission will disqualify the candidature.

- Please see the important dates and preserve it as a guide. All announcements from the institute will be through its web site: www.nmims.edu and no individual communication will be sent to the candidates. Kindly check website regularly for any updates.
- If at any stage, it is found that a candidate does not satisfy the eligibility criteria or the information furnished by him/her in the application form is incorrect, his/her admission to the course, even if selected, will stand cancelled and fees will be forfeited.
- Selected candidates' documents will be verified at the time of admission, and in case of discrepancies, the admission will be cancelled and fees will be forfeited.
- It is the sole responsibility of the candidates to ascertain whether they possess the necessary and requisite qualification for the admission to the courses at NMIMS.
